No. 1057-Agri. II (5)-2020/ 3783 .The Governor of Haryana is pleased to accord approval for implementation of Central Sector Scheme on Formation and Promotion of Farmer Producer Organizations (FPOs) in the States from the year 2020-21 with the following mechanism.

- Small Farmers Agribusiness Consortium Haryana (SFACH) is nominated as Implementing Agency of this scheme for Haryana State.
- Project Management Unit of SFACH shall act as Cluster Based Business Organization (CBBO).
- SFACH will encourage formation of FPOs with the concept of 'One Cluster One Product' in horticulture and 'One District One Product' in agriculture and allied sector.
- For effective implementation, evaluation and monitoring of the Scheme, State Level Consultative Committee (SLCC) and District Level Monitoring Committee (DLMC) have been constituted with the following compositions:


